Call to Order

The meeting was called to order at 10:00 am by the Chair, Mark Schoening.

Comments included that our goal is to heal the sin of the world (including in ourselves) and that we need to handle errors in our thought right away.

Abbreviated Reports from the Field (detailed reports are emailed to the reps and workers)

The worker from the Monroe Reformatory reported that he visited there three times this quarter. No one came for the second or the third sessions, but fortunately, one man did come to the first session in October. The inmate didn't know anything about Christian Science, but was interested and appreciated their coming. The worker had taken a Christian Scientist with him to this session who was interested in learning about this work.

There is a need for more C.S. used literature at KCCF and at RJC, both in English and in Spanish. This would include Sentinels, Heralds, Monitors, and Full Texts. Please notify a worker to arrange this if your church can help.

Coordinator's Report

At the church services presented at the Regional Justice Center in Kent this quarter on the second Thursday evening of each month, several men attended the first two services but a surprising thing happened at the last service! Two men came at the beginning of the service, and then other men began to trickle in, and by the time the service had ended, fourteen men were there! They enjoyed singing the familiar hymns that had been chosen. Some of the men signed up for visits and literature.

The Coordinator mentioned that it is important that in their prayers supporting this institutional work, our churches recognize that there is a real need in our communities for church services.

Old Business

Pat Matteson is no longer reading the Lesson Sermon to a resident in a retirement home on Mercer Island, because he has moved.

A discussion was held about the Area Committee Bylaw stating that a volunteer religious worker has to be a member of a member church or society of this committee led to the following motions:

MOTION: "That we grant an extension to any worker who has had his/her branch church/society closed and is still an active member of The Mother Church, a grace period of up to 6 months to become a member of another Christian Science branch church/society in King or Snohomish County." Seconded. PASSED.

MOTION: "That the Coordinator ask the Programs Director at KCCF if an active Christian Scientist religious volunteer worker may continue as an active worker for a period of 6 months after their present church/society has closed. Seconded. TABLED.

New Business

Byrne Lacomb recommended reading an article entitled "From the Directors," written by the Board of Directors of The Mother Church for the October 1980 *Christian Science Journal*. It talks about descriptions of some of the Christian Science church activities that are designated in the Manual to be observed by branch churches and societies.

The article points out that we should be alert to the intent of "Joint Activities" and to remember that branch churches are specifically <u>democratically</u> governed, not to be directed by any authoritative mandate of the activity they vote to join and to lovingly support. This, Byrne felt, is the intent of our Leader's guidance in MANUAL Art. XXIII Sect. 1. under which we in our institutional activity are operating.

The secretary reminded everyone that she has packets that describe Mrs. Eddy's interest and support of institutional activities for anyone who would like one.
